For these reasons, the order granting summary judgment is reversed and remanded. 20 Sudanese President Omar al-Bashir has been indicted by the International Criminal Court on charges of genocide, war crimes and crimes against humanity for the violence against the peaceful protest in the Sudanese city of Omdurman. Released by the ICC's Pre-Trial Chamber on Monday, the document alleges that Bashir and other senior members of his government had waged a policy of "collective punishment" against the civilian population in Darfur since before the protest on 19 December 2013 which started in response to the ruling of the High Court of Abyei which awarded land and resources to the landlocked province of Abyei and its breakaway region of Western Kordofan, both of which are parts of Sudan. "President Bashir himself ordered the deployment of extra-judiciary forces known as the Rapid Support Forces (RSF) in Omdurman on 13 December 2013... to carry
